### 2. Secretaries Report

### Loyal Savers See £850m Chopped Off In Six Months

Banks and building societies have since January knocked nearly £850m off the annual interest paid to savers, The Telegraph can disclose. The cuts coincide with banks making billions of pounds in profit in the first half of this year.

The clawback, buried in the details of a report published on
Monday 30 July by the Bank of England, affects existing
customers who hold easy-access savings accounts.

More than 750 cuts have been made to these accounts in just six months, despite the Bank of England Base Rate remaining unmoved at 0.5pc.

The sharp reduction in interest handed to savers coincided with Britain's biggest banks making billions of pounds in profits for the first half of this year.

Cuts to rates used to lure new customers in the wake of the Government's Funding for Lending Scheme - which a year ago gave banks access to £80bn of cheap capital - have been well documented.

For example, High Street giant HSBC used its access to market data to calculate that savers with fixed-term bonds maturing in 2013 will see their incomes reduced by a combined  $\pounds1bn$ . This is simply because the rates on new fixed-term products are so much lower than the returns on their existing deals.

The Bank of England figures released w/c 29 July were backed up this analysis, with the Telegraph reporting that the interest on longer-term savings products has fallen to a nine-year low. For example, the average interest paid on one-year bonds has fallen from 2.06pc to 1.85pc in the month of July alone. It is the first time the figure has dropped below 2pc since records began in 2004.

However, deeper analysis of the report exposes banks for hacking back the rates paid to loyal savers as well. These movements are made behind closed doors, never publicised and therefore rarely scrutinised.

The average rate on all easy access accounts is now just 0.97pc, down from 1.14pc in January, the figures show.

This is equal to a miserable  $\pounds485$  a year on each  $\pounds50,000$  of savings, compared with  $\pounds570$  in January - a reduction of around a sixth.

By shaving 0.17 percentage points off the return they pay loyal savers banks have been able to swell their coffers, as the lower outgoings free up cash to use in more profitable parts of the business. This is typically lending arms, where banks are taking advantage of renewed enthusiasm in the property market.

Based on the total amount of money in easy access accounts -  $\pounds$ 496bn according to the latest Bank of England report - this amounts to  $\pounds$ 843m in lost annual interest.

In-depth research for the Telegraph by rate monitoring website Savingschampion.co.uk found that banks have significantly increased the number of rates chiseled away each month since the turn of the year.

Between January and July 2012 an average of one bank or building society each month cut the rate on an account held by existing customers.

The figure jumped to 24 during the first half of 2013. A total of 750 rates cuts were made in the six month period. Just 86 cuts were made during the entirety of 2012.

Anna Bowes, director of Savingschampion, said: "These figures show how much Funding for Lending has hurt savers. Not only has this removed the need for providers to attract new customers, but it has had a knock on effect on the back-book business of existing customers.

"This is highly unusual and a very unexpected development. Traditionally, back-book easy access rates have only changed when bonus rates fall off or Base Rate is reduced."

The figures come just as banks enter their reporting season at the end of July. Barclays reported profits of  $\pounds$ 3.6bn on 30 July, while Lloyds Banking Group, which includes Halifax, is expected to deliver profits of  $\pounds$ 2.3bn. *Source: Dan Hyde Daily Telegraph 31 July* 

# Company News: Dow Corning Sees Collaboration in Materials and Processing Technology as Critical to the Semiconductor Industry's Recovery

MIDLAND, Mich. – Semiconductor sales appear to be finally emerging from the red this year, with moderate but steady growth of 5.1 percent projected through 2014, according to World Semiconductor Trade Statistics' Spring 2013 global semiconductor sales forecast. While a revival in end-market demand is sparking much of

this growth, Dow Corning, a global leader in silicones, silicon-based technology and innovation, sees collaborative advances in materials and processing technologies as a sustaining force in the industry's recovery.

"The pace of innovation across the semiconductor processing and packaging value chain has never been greater and, while the industry hasn't reported any insurmountable challenges ahead for advancing such promising technologies as 3D IC integration, several critical needs are emerging among our global semiconductor customers that we are addressing head on," said Andrew Ho, global industry director, Advanced Semiconductor Materials at Dow Corning. "Among these needs are the steadily accelerating demand for high-performance silicone solutions to help collaborators along the value chain to manage the impact of heat and stress, while reducing overall systems costs wherever possible."

Specifically, Dow Corning sees growing demand for innovative new silicone solutions able to address the following industry-wide challenges:

Improved heat management: The trend toward ever-smaller devices with more densely packed electronic components is coinciding with the expanding use of flip chip and stacked die architectures. As a result, the industry is seeking improved thermal management from advanced silicone technologies that effectively dissipate heat and deliver greater device reliability and longer life.

Enhanced stress passivation: The rapid growth of wafer-level packaging and power electronics is posing new manufacturing challenges for stress mitigation. At issue is thermo-mechanical stress failure caused, in part, by conventional organic passivation materials. This has prompted new explorations in photopatternable silicone solutions that help minimize thermo-mechanical stress during processing, and deliver higher thermal stability and low temperature cure.

Lower systems costs: Minimizing total cost of ownership is essential for all semiconductor manufacturing applications. But it is a key enabler for next-generation technologies, such as 3D IC integration built on ultra-thin active wafers. These wafers are temporarily bonded to a carrier wafer before being thinned; yet most temporary bonding solutions require costly pre-treatment and specialized chambers. Recent industry collaborations, however, have successfully fielded a simpler, more cost-effective temporary bonding solution based on silicone adhesive and release layers. The breakthrough technology now enables room-temperature bonding and debonding of active and carrier wafers using conventional manufacturing methods.

"After decades of serving the semiconductor manufacturing industry, Dow Corning recognizes that few if any companies can single-handedly anticipate the next-generation of semiconductor solutions," said Ho. "Our strong leadership position in this industry is directly linked to our long history of close collaboration with semiconductor manufacturers to develop breakthrough silicone technologies, and we are committed to continuing our history of proactively collaborating with customers to solve their most pressing challenges and help drive the industry forward."

## DCRA "FRIENDSHIP" CHARTER – Concept Document Rev 03

### PURPOSE:

The purpose of the DCRA Friendship Group would be to provide specific support to worthy (in need) DCRA members, primarily in response to a request direct from a member requiring support, or reference via the close family, or a friend. In other cases the Friendship Group may contact a member directly and offer a service. The provision of the DCRA Friendship services is not to substitute or replace the state or local authority service, but it may compliment some state or local authority services.

### SCOPE OF FRIENDSHIP PROVISION:

The scope of Friendship provided by the DCRA Friendship Group is primarily "assistance in kind" but not financial assistance.

The "Assistance In Kind" may include, but not be limited to:

- Hospital visits
- Home visits
- Running errands
- Short transport journeys (up to 30 miles)
- Point of contact if no other local supporting family or friends available

The decision to provide or not provide support would rest with the group member attending the person in need of support.

There may need to be some restriction on area serviced (30 miles max from impacted member to support worker) in which such support can be effectively administered if a house visit is required. However, if support request/s can be resolved by telephone or e-mail, then the support worker may decide.

### FORMATION OF FRIENDSHIP GROUP:

The DCRA Friendship Group would require the following membership to function

effectively

- DCRA Friendship Group Coordinator, plus a deputy to cover absence
- DCRA Friendship Group Support workers with a wide range of attributes contained in a register.
- Note due to the potential one on one interaction with vulnerable people, support workers will need CRB (Criminal Records Bureau) checks carried out.

### ADMINISTRATION PROCESS:

A member (directly or via a representative) in need of support would contact the DCRA Friendship Group Coordinator and request type of assistance required. The Coordinator would either e-mail or telephone group members making a request for attendance to impacted person, type of assistance required, geographical location and some indication of level of urgency. (It may be beneficial to name the impacted member as past friendships may have a bearing). The supporting Friendship Group Member would indicate willingness to attend and would then receive the contact details. On completion of assistance the supporting Friendship Group member would Coordinator that request/s communicate to the have been executed, (or that some are still outstanding and outside of the support worker's capabilities) and submit any agreed incurred expenses to Coordinator.

In the situation of a DCRA member not requesting support, but that others are aware that assistance is required, the Coordinator could contact the relevant member to establish if assistance was required.

(The above may be better illustrated on a flow chart).

A record of impacted members requests and task undertaken might be retained by DCRA Friendship Coordinator to allow measurement of services given and potentially prevent abuse of the system.

### **INCURRED EXPENSES:**

Expenses incurred directly associated with the support function by Coordinator or support workers should be recompensed from DCRA Treasurer. Travel expenses to be from support workers home to the home of the member receiving support and/or during tasks requested by the member. Travel expenses would be paid at current AA rate (44p/mile in 2013). It is envisaged that expenses would be limited to travel expenses only. Expense claims should be directed in the first instance to the DCRA Friendship Group Coordinator for review and approval with subsequent payment by DCRA Treasurer. All material content and costs are to be borne by the member receiving support.

### DONATIONS:

Should the impacted member wish to make a donation for assistance given, these monies should be directed to DCRA Friendship Group Coordinator or DCRA Treasurer.

### DATA PROTECTION:

All participating members must respect the Data Protection Act and the privacy and confidentiality of the individual member receiving support, the support worker and their contact details. Once the support worker has

completed the task for the member, all confidential information should be destroyed, although it may be retained by the DCRA Friendship Group Coordinator.

As part of the implementation of the Friendship Group, additional membership information to that that currently held will be sought during membership renewal time, i.e. Date of Birth, Next of Kin name and contact details.



The June walk was based on Llanfrynach just to the east of Brecon. Five walkers slowly climbed up the ridge and the escarpment to Fan Y Big (719 metres) having stopped for lunch in an old grass clad quarry overlooking the Cwm Oergwm valley with Llangorse Lake in the distance beyond. The walk down the Cefn Cyff ridge back to Talgarth was a delight in good weather and with superb views. This walk was 12 miles, challenging, but most enjoyable.

In June, eleven walkers visited Andalusia in Spain's Sierra Nevada mountain range for a weeks walking. We stayed in a small village in the foothills at a very comfortable, rustic hotel owned by a young British couple. The food (locally grown, local recipes and the cooks were local too) was to die for. We walked each day, sometimes all downhill! The highest peak reached was at 2600 metres or about 8500 feet. The weather was a walker's dream, no rain, cooling breezes but no strong wind and a temperature of between 22 and 28C. The walking was excellent too, mostly on good paths or grass. We all agreed that we would like to return.

The July walk started from Talgarth and took in Bronllys Castle, Llanelieu Court and Pwll-y-Wrach Nature Reserve, all worthy of a visit in their own right, before returning to Talgarth, making a very enjoyable 10 mile walk that had been proposed by Peter Davies. We had to visit the recently refurbished Talgarth Mill for tea and cake to round off a very pleasant day for the seven walkers who turned out.

In August we returned to the central Brecon Beacons for a classic walk – the Pen Y Fan Southern Horseshoe taking in the peaks of Corn Du, Pen Y Fan, Cribyn and Fan Y Big. Pen Y Fan is the highest peak in southern Britain at 886 metres or 2906 feet and is a magnet for hill walkers and being so close to the A470 is well visited by hoards of walkers throughout the year. We avoided the hoards by walking up from the Lower Neuadd Reservoir and climbing up onto the escarpment, where unfortunately one of the TA Reservists died recently undertaking a SAS selection exercise. The weather was kind to us and we had lunch just below Pen Y Fan summit and returned to the cars after climbing the last peak by walking along the Drover's road. Excellent!

(A) Friendship Charter (Document Rev 03) Proposed by Richard J. Thomas

Sixteen members voted in favour for the team to go forward with the draft proposal and consider what the cost implications are necessary or an individuals vehicle insurance policy if used to convey people to and from hospital appointments etc. Joan Lake mentioned any association member or their wives who have previously served in the forces can contact her via the British Legion for this sort of assistance. The team now need to look into all aspects of travel, CRB checks, insurances etc. and report back at the December meeting. If satisfactorily answered, Val will put a request on the membership renewal form asking for volunteers. Richard is of the opinion 20 volunteers would be ideal.

(B) Reduction in Honorariums: Payments to committee members exceed the income from renewal fees therefore the full committee propose to reduce honorariums as shown below. Executive committee members and membership secretary currently £60:00 proposal £40:00

Committee members currently £40:00 proposal £20:00

Trip Organiser classed as committee member above however if an agreed number of short breaks/ day trip were met, this payment would increase by another  $\pounds 20:00$  to bring the total to  $\pounds 40:00$  plus any out of pocket expenses would be covered.

Skittles organisers currently  $\pounds 40:00$  proposal  $\pounds 20:00$  however if the organiser is already a committee member then additional  $\pounds 10:00$  payment would be received for providing four or more events annually. *Proposed by Richard J. Thomas* 

A vote was taken and the majority present at the AGM agreed with the reductions.

(C) The full committee proposed a change to the month the annual subscription payment is normally due moving from October to January that will be in-line with the annual audit of accounts. The change will mean a word change to item 8 of the constitution from October to January. Proposed by Richard J. Thomas / Val Caple

Accepted by all 22 members present.

(D) Full committee proposal to alter the wording from half yearly to quarterly within item 15(b) of the constitution. Shop staff will now be paid quarterly in April, July, October and January as opposed to half yearly which is far too long to wait for payment. *Proposed by Don and Gloria Surridge* 

Accepted by all 22 members

Everyone was in favour of the proposal and retaining Don as Chairperson for another 12 months which Don accepted. However a new secretary will need to be found after the December meeting.

(G) Annual Dinner 2014 (May Period)

The social team led by Derek Butler have considered various locations and have decided that the Masonic Hall will be the venue for this event. It can cater for 80 plus and entertainment will be provided. Tickets will state 'Dinner/Entertainment' there will be NO dancing. Derek will continue discussions with the caters et al and the social team will offer full details / costs at the December meeting.

(H) The Equitable Life Payment Scheme has been set up by the Government for just under a million policyholders who lost £4.3 billion through the poor regulation of Equitable Life.

In October 2010, the Government announced, given the strain on public finances, it would pay out  $\pm 1.5$  billion to these policyholders.

In the near future, you will receive a letter informing you of the compensation payable to policyholders within occupational pension schemes who previously held With-Profits AVCs with

Equitable Life. The Government has appointed ATOS Consulting to coordinate the payment of compensation to eligible individuals on its behalf.

However, you should note that not <u>all</u> individuals will be eligible. If you currently hold or previously held AVCs with Equitable Life you should be contacted by ATOS Consulting directly in the near future. *Source: Dow Corning Pension Plan (Newsletter)*
