SECRETARIES REPORT

During June, July 2015, the executive committee were please to welcome the following new members: Gail Stephenson and Peter & Diane Armstrong.



Nature conservationists have discovered a rare moth species at Dow Corning's Cadoxton Ponds nature reserve in Barry.

The Wildlife Trust for South and West Wales (WTSWW), which help maintain the biodiversity of Dow Corning's 30 acre nature reserve, recorded the species whilst carrying a regular monitoring activity. It was the first time the moth species, called *Anania perlucidalis*, was spotted in Glamorgan county and only the third time it has been seen in Wales. The species was first recorded in the United-Kingdom in 1957.

The recently spotted *Anania perlucidalis* can be found in Europe between June and August. It has a wingspan of approx. 20mm and preferably inhabits wetlands such as marshes and reedbeds, which are relatively scarce in the local area. Over fifty moth

species were recorded during this latest overnight moth trapping exercise, including this very notable one.

Since the start of the collaboration between Dow Corning and the Wildlife Trust for South and West Wales a few years ago, a range of species surveys has been carried out, including birds, butterflies, small mammals, reptiles and amphibians. Dow Corning's Environment Officer, Catherine Lewis, said: "These surveys have produced an already impressive species list for the site with a number of scarce or rare species having been recorded, such as bittern, harvest mice, shrill carder bees and small blue butterflies. This latest finding demonstrates yet again how wildlife and industry can co-exist".

Cadoxton Ponds is a 30 acre nature reserve created by Dow Corning on land adjacent to the manufacturing site. The reserve is also home to an Education Centre, which can be used by schools and local groups for environmental studies, field trips and science projects. Dow Corning encourages educational visits and offers various activities to support the sustainability curriculum that schools follow.

I recently sent out an email invite to our membership and their grandchildren for a talk and walk of the nature reserve with Catherine. Settling into our new home I forgot to invite members who are not on email - sorry. Both dates offered were during the schools summer recession. The above photograph for my report was provided by Dave Townsend. An additional report by Diane Baker will be included in Val's newsletter. If you have any interesting item that you would like to see added to our newsletter, please send to Val Caple this month.

Along with our chairman and treasurer we recently had discussions with Thomas Carroll brokers Limited regarding Public Liability insurance cover. Thomas Carroll having been chosen as a recommendation from Age Cymru.

Public Liability Insurance exists to handle claims made against DCRA by the public for damages from injury or property damage. If through the "negligence" of an Active Group when organising an activity some person (be they members, or the general public) suffers an injury or property damage, the committee and members of the DCRA could be held personally liable to pay compensation to the victim(s).

What is covered is the legal liability of DCRA for claims made against it for injury or property damage by the general public. This gives our members peace of mind, as they know that should they suffer an injury by accident on any Active Retirement activity, the financial burden an accident can bring will be eased for them and for their families. The annual policy for the next twelve months will be £316:50.

We 'the executive committee' require your support and ideas of how best to take this matter forward today.

News from Dow Corning

Dow Corning Corp. on July 29 announced second quarter sales of \$1.42 billion and net income of \$113 million. Adjusted net income in the second quarter increased 27 percent to \$127 million. Through the first half of the year, Dow Corning's adjusted net income, which excludes unusual items, has increased 9 percent despite decreased sales impacted largely by the strong United States dollar.

Our June walk was the classic Northern Pen Y Fan horseshoe, 9 miles and challenging, starting from Cwm Gwdi. It



incorporates climbing Cribyn, Pen Y Fan (886m – the highest peak in southern Britain) and Corn Du, before descending into the beautiful Cwm Llech with a lake, woods, pastureland and a gurgling river. Five walkers took part in cloudy, breezy weather. We stopped off at the Drovers Arms on the way home to celebrate Anne Dams re-joining the group after her injury in March.

In June, sixteen walkers travelled to Guernsey for a week long walking holiday. We walked around the coast paths of Guernsey, Herm and Sark, a total of 55 miles with over 8000 foot of ascent, most of it felt like the first two days in Guernsey. Weather was

mixed, three days of sunshine, two days of wind and one day of rain, unfortunately this whilst we were on Sark. We were based in St Peter Port.

Grwyne Fawr Valley, Blacksmith's Anvil, Twmpa (also known as Lord Herford's Knob), Rhos Dirion and Grwyne Fawr reservoir were all feature points for the July walk above Abergavenny. It was a 13 mile, challenging walk undertaken in cloudy conditions with rain later forecasted. What a laugh was had by fellow walkers!

- Estimated to be +/- 2000 retirees living in the Tri City area
- Membership of Retirees Association is 563..... maybe 25 % (have to have been a DC employee)
- Of those the number attending meetings is 100 to 20025 to 50 % (can include spouses of members who've died)
- Tends to be R&D and Production very little management

Meetings

- 8 meetings a year 3rd Wed of each month except Jan, Feb, July, Aug
- All are lunches in Ramada Inn
- June (picnic) and December (Xmas party) have prizes
- One mtg will include DC Management address
- One mtg will have DC Benefits address
- Four mtgs with outside speakers (occasionally visit elsewhere)
- Retirees in Florida one golf mtg which DC Mgr attends.

Activities

- Used to have bus tours not now
- Two golf meetings

Structure

- 12 directors, one of them chairman with other appointed posts
- Board meets once/month (hour) usually prior to lunch mtgs (8 in total)
- Business typically minutes, critique of last lunch, future planning
- No AGM
- If someone wants to stand down and have replacement, arranged at meeting and approval at next lunch

Pension/Benefits

- No annual increases to US pensions
- Fixed pension company provides on retirement
- "Cap Plan" is a bit like AVCs company would match \$5 for \$8 employee invests. DC manages plan. DC argument this investment grows......bit like scheme now introduced for employees at Barry
- DC Healthcare this used to be provided through DC. This has recently changed with company saying it could not afford each individual given sum to make their own arrangements (2000 USD/person/yr)
