Secretaries Report

We have been invited by Age Cymru to take part in gentle 'Nordic walking' programme to suit our association members. You walk using a pair of specially designed, lightweight poles l**ge** Cymru that provide additional support meaning you get more from the exercise.

Nordic Walking provides a numbers of benefits above that of normal walking.

It exercises 90% of your muscles increasing strength in your legs, arms, shoulders, chest and back.

Nordic Walking is less tiring than normal walking and it can increase your heart rate by up to 13% meaning that you receive greater benefit through less effort.

Age Cymru provide the five lessons at a mere cost of £10:00 which includes the loan of poles specially suited to you.



Having personally taken part in the programme, lessons were suited to my timeframe, distance and location. Most have been held either in Cosmeston or Porthkerry Parks. Pavements is NOT a problem

The instructor adapts to suit individuals. Training can be on a one to one basis or in small groups.

Nordic walking was discussed during a recent committee meeting and we feel the programme should be offered to you as members. Therefore we have invited two instructors from Age Cymru to discuss the programme at our March meeting pointing out the advantages of Nordic walking.

I am sure the talk will be interesting and encourage some members to participate.

One thing that it is not and that is strenuous. For just ten pounds for five sessions and the use of Age Cymru's walking poles (so no initial outlay for poles) and with a qualified instructor there is not too much to loose.

As with any exercise programme, people with health issues should always consult their doctor before commencing any programme.

Third Quarter Results

Dow Corning Corp. announced third quarter sales of \$1.52 billion, a 7 percent increase compared to 2013. Net income also increased to \$176 million, representing a 49 percent increase compared to the third guarter of 2013. For the year, Dow Corning's sales (\$4.54 billion) and net income (\$476 million) have increased 10 and 78 percent, respectively.

Adjusted net income through the third quarter of 2014 was \$318 million, an increase of 58 percent compared to 2013. Adjusted net income for 2014 excluded the impact of a derivative contract, long term sales agreements and a tax benefit associated with foreign dividends. Adjusted net income for 2013 excluded the impact of a derivative contract, long term sales agreements, charges for impaired assets and restructuring expenses. 
- Silicones sales grew in the Americas, Greater China and Europe

Current deficit for the year is £37.59

Walking Group Report



The September walk was undertaken under sunny and showery conditions starting at Chepstow bridge and following the Wales Coast Path to Caldicot. The walk coincided with a spring tide but the path was clear of water by the time we walked through. We had left our cars at Caldicot and taken the bus up to Chepstow (bus passes at the ready, of course) so on return to Caldicot we took some liquid refreshment before setting off home. The walk was 11 miles and although quite flat was

enjoyed by ten members and turned out to be very interesting as it snaked along the shoreline.

In October we took a new route, recommended by Robin, up onto Sugar Loaf above Abergavenny. Ten walkers started the 9 mile challenging walk from Cwrt Y Gollen training camp on the A40 and approached Sugar Loaf at 596 metres from the west flank. Lunch was enjoyed at the summit hiding from the rain and wind that welcomed us as we arrived at the top. The return route was made more interesting in that we had problems finding the path in places and then met three inquisitive horses that followed the group for quite a distance asking if Stuart knew the way, or was it the Welsh cakes in George's rucksack? We agreed it was a good walk. Thanks Robin, even though you were unable to join us.

The November walk was on the 5th, so we started 30 minutes earlier than normal so we could get home to celebrate Bonfire night with our families. It was centred on the Black Mountains above Crickhowell and featured two fine ridge walks with superb scenery. Of course you need to climb up to the ridge first, so six walkers put their best boots forward and plodded up to near Table Mountain before the ascent up onto Pen Cerrig Calch (translated means white or limestone rock) at 701 metres. The first ridge took us along to Pen Allt Mawr (big high hill) at 719 metres, but we stopped part way along to sit in a ring of stones in the sunshine to eat our deserved lunch. We descended the north nose of Pen Allt Mawr across a boggy section, before turning right at a pile of stones to descend the second ridge in glorious sunshine back to the farmhouse and our cars. A fine walk – one of the best ridge walks in the Beacons.

Our December walk will be in the Vale of Glamorgan and on the Wales Coast Path based on Horse Shoe Inn at Marcross where we will partake of our Christmas Lunch.

During 2014 group members have walked over 270 Km (170 miles), climbed up nearly 7500 metres (24,600 feet) and had over 180 turn outs of members on walks. It has been a good year. It helps to keep us fit and happy.

The 2015 DCRA Walking Group Programme will be published and distributed in December with walks proposed by members.
