WALKING GROUP:

In June ten members visited the small Maltese island of Gozo for a week long walking holiday to enjoy the warmth of the sun, good food and relaxed island walking routes. We were based in a luxurious boutique hotel in the centre of Victoria and our walks very often took us to a nearby beach for lunch, a swim and either a walk back or return by bus. The coastal walks were stunning and quite remote on occasions, but the weather was hot so we made plenty of café stops for cold drinks when we reached civilisation. A great holiday – one of the best. Gozo is a gem of an island.

The July walk had us returning to the Carmarthen Vans and Black Mountain for a classic walk. The start was from Llandduesant and we wound our way above Llyn y Fan Fach (of Lady of the Lake fame) up onto Bannau Sir Gaer, Picws Du, Fan Foel and finally the highest point on Fan Brycheniog at 807 metres before descending to circumnavigate Llyn y Fan Fawr and back under the towering dark escarpments, passing close to the sources of both the Tawe and Usk rivers. Blaenau farm unfortunately has stopped serving cream teas so we had to make do with an energy bar to finish off a wonderful walk. The weather was kind to the 8 walkers thanks to Mike Dams, who has been appointed as Derek Brockway's deputy and apprentice to David Bailey. Thanks for all you do Mike! It is appreciated by all.

The adverse weather forecast on 2nd August caused the postponement of the walk until 16th August (when unfortunately Mike Dams was not available) but the weather was acceptable, being dry, with sunny periods, albeit a bit windy on the top at Waun Fach. We started the walk at Pengenffordd just south of Talgarth and climbed steeply up to Castell Dinas for a coffee break before making our way up the Dragon's Back. At the top we turned towards Waun Fach at 801 metres only to find that someone has removed the trig point, but kindly laid some very good paths across the peaty moors. The eight walkers were very disappointed not to be able to get a much needed, refreshing pint on return to the Dragons Back Inn (previously known as the Castle Inn) but happy having experienced another fun, but fairly strenuous, 7 mile walk.
