We had 23 people attend the meeting. Thanks to all for turning out on such a wet day.

Chairman update

Trevor welcomed everyone to the meeting and hoped they had a good Christmas and wished everyone a happy new year. Apologies were read, and others added from members at the meeting.

Secretary update.

Meeting minutes from last meeting were reviewed, details given at the end of these minutes.

Treasurer update.

Margaret gave details of the accounts. DCRA finances are OK at present with 5033.90 in current account and 1663.77 in savings account and are all up to date with no outstanding costs.

There is no income apart from membership subscriptions but there are sufficient funds to continue the DCRA for the near future.

To reduce expenditure, it was decided at the EGM in November 2017 that there would be no tesco vouchers given to members from now on. We will also not send £10 to people in Hospital but we will continue to donate £20 in the event of a member's death to charity of the family's choice. Walking group report

DOW CORNING RETIREE'S ASSOCIATION WALKING GROUP REPORT TO 15th JANUARY 2018 MEETING

In September five members met at Neuadd Fawr farm and had an enjoyable 8 mile, albeit wet and windy walk up towards Table Mountain (above Crickhowell, not Cape Town) before the final ascent up onto Pen Cerrig Clach, along to Pen Allt Mawr, having had lunch in a sheltered spot. The views from the tops were extensive before we dropped down and made our way along the ridge back down to the farm. The heather was unfortunately past it's best, so next time it needs to be in July or August.

The October walk was a Beacons 'classic', incorporating two long ridge walks and 4 summits (Corn Du, Pen Y Fan, Cribyn and Fan Y Big). 7 walkers turned out for this 8 mile, challenging walk but were rewarded for their efforts with reasonable weather and fine views, plus some newly paved areas that had previously been boggy or mud baths - thanks to the Brecon Beacons Park Authority and the Society volunteers work.

We ventured out west for our November ramble, all the way to Llanelli, no less. The plan was to complete a short walk, have lunch and then visit the Wetlands Wildfowl Centre, but after a review of time and costs, we decided to complete a longer walk in the Swiss Valley that turned out to be very pleasant, with a number of interesting features like lakes, cycle paths and railway preservation sites. Twelve walkers completed the walk and some vowed to visit the Wetlands independently in the future.

In December we couple a short walk with our Christmas Lunch and this year we had chosen the Six Bells at Penmark for lunch with a four mile walk around Llancarfan. Stuart recce'd the proposed Llancarfan walk the weekend before and found the walk very muddy with part of the return route underwater, in fact the ducks had settled in. So on the day, fourteen of us walked from the Knap pebble beach to Porthkerry and back on the Wales Coast Path before enjoying a delightful lunch at the Six Bells. We were greeted by scores of chickens when we crossed the car park back to our cars.

During 2017 the group walked 144 miles, taking 81 hours, climbed over 22,000 feet with 168 turnouts. No doubt this amount of effort helps to keep us fit and happy.

The 2018 Walking programme was issued to the 45 members of which 28 have been active, plus we have been blessed with 3 new, young members during the year. The New Year started in customary style by walking up to Pen Y Fan on New Year's day, with whisky toasts and text messages to family and friends, all finished off with hot mulled wine and mince pies on our return to the cars. A Happy New Year to you All.

The January walk from Caerphilly Common. Via Craig yr Allt and Taff Trail was local and at low level to accommodate potential winter weather issues, which on this occasion came in the form of storm force winds that encouraged the postponement for seven days. 13 walkers turned out for the 8 mile easy/moderate walk in fine weather thanks to our weather man Mike Dams (also photographer, hang back organiser and historian) but we did encounter two significant muddy patches enroute. Much Yuk!

Potential Changes to the constitution

The name of the Association is DOW CORNING RETIREES' ASSOCIATION, hereinafter referred to as 'the Association'.

2. Objectives

To promote communication, sport, recreation, welfare and social activities.

3. Membership

Membership shall be available to:-

- a) Retirees from the Barry factory and those in receipt of a pension from Albright & Wilson Ltd., Midland Silicones Ltd., or Dow Corning Ltd. whether directly from those Companies or from a company administering their pension funds.
- b) Husbands, wives or partners of retirees
- c) Widows and widowers of retirees.
- d)Retirees from Albright & Wilson Ltd. & Midland Silicones Ltd.

The representative to attend the Trustee Pension Fund Committee meetings as an observer must be a Member of the Association and his/her selection ratified at a properly constituted Members' meeting.

4. Register of Membership

The register of Members will be kept by the Membership Secretary.

5. Membership Cards

A membership card will be issued to each individual Member whose subscriptions are

6. Cancellation of Membership

Membership shall be cancelled in the event of non-payment of subscriptions after two reminders have been sent in addition to the annual notice requesting payment.

7. Restoration of Membership

If a membership has lapsed through nonpayment of subscriptions or for any other reason the membership can be reinstated on payment by the Member of a fee of £3 towards administration costs.

8. Subscriptions

There shall be a membership fee, paid annually in advance, on the 1st January. The amount of the subscription shall be decided at the Annual General Meeting to be effective from the 1st January.

9. Annual General Meeting

- a) The Annual General Meeting will be held at 2:00 p.m. on the first Monday in September, or on such approximate date as shall be convenient for the use of Dow Corning
- b) Each Member present at the meeting shall be entitled to one vote. Voting will be by simple majority.

10.Meetings

- All Quarterly meetings shall be held on the first Monday in December, March and June or on such approximate date as shall be convenient for the use of Dow Corning facilities. Additional meetings may be arranged as decided by the Officers of the Association.
- b) Each Member present at the meeting shall be entitled to one vote. Voting will be by simple majority.

11. Extraordinary General Meeting
An Extraordinary General Meeting may be called by:

- a)The Management Committee, providing that not less than one month's notice of the matter to be discussed is given to all Members in writing.
- by The Secretary, on receipt of a notice signed by not less than thirty Members, giving not less than one month's notice requesting the meeting, together with a written statement of the matter to be discussed.
- Each Member present at the meeting shall be entitled to one vote. Voting will be by simple majority, except for alteration of the Constitution.

12.Officers

The Association Officers shall consist of Chairman / Chairperson, Secretary and Treasurer. They shall be elected at the A.G.M. for a term of one year. At least two of the Officers must be ex-employees of Dow Corning Ltd.

13. Management Committee

The Management Committee shall consist of four Members elected at the A.G.M. for a term of one year, and one liaison Member nominated by Dow Corning Ltd. management. The Management Committee, hereinafter referred to as 'the Committee', shall:

- a) Consider itself as having a quorum if two Officers and two Members are present.
- b) Have the power to co-opt Members of the Association as it may deem necessary.
- c) Have the authority to set up sub-committees and to delegate to those sub-committees such power and responsibilities as is deemed necessary, also to disband these sub-committees as required.
- d)Be responsible for carrying out the objectives of the Association by managing its affairs in a right and proper manner.
- e)Not having the power to dispose of the Association funds except for normal expenditure.

- a)Lloyds TSB Bank Plc is to be used for Association funds.
- b) All cheque's must be signed by the Treasurer and countersigned by either the Chairman or Secretary.
- c)The Treasurer is responsible for the receipt of all monies belonging to the Association and will keep a record of all transactions, and will prepare an annual statement of Income and Expenditure and Balance Sheet for approval at the A.G.M.
- d)An independent audit of the accounts shall be carried out annually.

15. Payments to Officers, Committee Members and Shop Helpers

- a) Subject to the approval of Members of the Association, honoraria payments may be made to the Officers and members of Committees. The amount of such payments shall be recommended by the Officers to the Members at the A.G.M. and voted by a show of hands.
- b)Subject to the approval of Members of the Association, fixed amounts may be paid to helpers at the Site shop, as a contribution towards lunch and travel expenses.

Relief Manager is paid by Dow Corning-Payments will be made quarterly. In April, July, October and January:

16. Alteration to the Constitution

Any alteration to this Constitution may only be made with the approval of:

a)An Annual General Meeting, providing that not less than one month's notice of the proposed alteration is given in writing to the Secretary.

Secretary.

b) An Extraordinary General Meeting called in accordance with rule 11 a) or 11 b). There shall be one vote per Member present at the meeting. Voting will be by 2/3rds (two thirds) majority.

No voting to amend the Constitution shall take place unless a minimum of 20 Members is present.

17. Dissolution

Dissolution of the Association shall be agreed at the A.G.M. Or at an Extraordinary General Meeting called in accordance with rule 11 a) or 11 b).

Approval of dissolution shall be by 2/3rds (two thirds) majority.

If it is decided to discontinue the work of the

Association, after payment of expenses and liabilities, any money remaining shall be donated to charities agreed by the Members by a simple majority.

18. Date of Adoption of and Amendments to the Constitution

Original Constitution Amendments September 1983

December 1983 September 1984 February 1988 September 1991 November 1995 September 2002 September 2012 September 2013



The most recent constitutional amendments that was approved by voters came in the September 2013 AGM, when voters approved a change to item 8 Subscriptions changing the month of payment from October to January.

The other approved alteration was to item 15 (b) adding Relief Manager is paid by Dow Corning and $payments\,will\,be\,made\,quarterly.\,In\,April, July, October$ and January.
