DOW CORNING RETIREE'S ASSOCIATION WALKING GROUPREPORT TO 12th MARCH 2018 MEETING

The February walk was a local, lowland, short walk of 6 miles based on Dinas Powys. After leaving the Star Inn car park we walked across the Dinas Powys Golf Club grounds to drop into Cwm George before passing the entrance up to the hill fort and onwards across a farmland path to Michelston le Pit. We walked past the four ponds known as the Salmon Leaps and up through woods with a stream gurgling in the bottom to reach Wrinstone Farm. At the top of the hill we had some good views from the farm track before returning to Michelston and the path back through Cwm George, the prescribed route across fields being full of sheep and too muddy. Before returning to the Star Inn for lunch we passed near Dinas Powys castle ruins, Tim Hellis's house and walked up Broth Lane to build up an appetite.16 walkers enjoyed this outing. Two new walkers joined the group for this rural ramble.

After experiencing 'The Beast from the East' with degrees of cabin fever and needing to blow some cobwebs away we ventured down to the Gower for our March walk, a 9 mile easy/moderate trek along Rhossili beach (3 miles), through Broughton Burrows, then contouring around Llanmadoc Hill to arrive at the Kings Head in Llangennith for a well-earned lunch. The return leg took nine walkers up over the Downs, with superb views from the trig point before returning to the Worms Head car park, whilst two returned via the beach. Swansea city traffic proved problematic on both journeys. The weather was kind to us right up until we were taking our boots off, then it hailed!

In order to satisfy the incoming General Data Protection Regulations (GDPR) on May 25, I have requested all existing DCRA Walking Group (45 members) to provide their consent to me holding their contact information in a secure data base solely for use on walking group matters. To date 29 consent
