A question we have been recently asked is, can spouses join the gym? WALKING GROUP REPORT:

The annual New Year's Day climb up onto Pen Y Fan was cancelled this year owing to adverse weather conditions. No walk or mince pies, mulled wine or whisky. Shame

The scheduled January walk was held around the Merthyr Mawr dunes system, starting at Newton church, walking along the Wales Coast Path and up the River Ogwr estuary to Candlestone Castle which was duly inspected before having lunch nearby. The 13 walkers returned to Newton by paths through the dunes, having completed the 7 mile, easy walk, before retiring into the nearby hostelry for refreshments.

February's walk was closer to home and at low altitude to avoid the vagaries of winter weather, especially on the Brecon Beacons. The 9 walkers led by Mike Dams started the 8 mile walk at Castell Coch and walked along part of the Taff Trail before descending and crossing the River Taff itself. The stiff climb up to Gwaelod y Garth and then up onto Garth 'Mountain' at 1009 feet, was completed in good time, before descending back over the Taff and back to the cars for some of the group to slip off for their pressing appointments. A lovely walk in good company.

A look at Merthyr Tydfil area's glorious history in the industrial revolution and in particular iron making was the background for our March walk on St David's Day. We walked from Cyfarthfa Castle, taking in cast iron bridges, blast furnaces, Taff Trail, viaducts at Cefn Coed and Pontsarn, iron-master Robert Crawshay's church at Vaynor and his huge tomb, a Norman church crypt on top of Morlais Hill, tramways, nature reserves, leats. It was a gem of a walk for the ten walkers who covered the 10 miles buoyed up on Barra Brith and Welsh Cakes. We even had good weather!

Membership of the Walking Group has increased by three in 2017. That's good news.

The Rescue Centre has chimpanzees, orang-utans, gibbons, capuchins, marmosets, woolly monkeys and 11 ring-tailed lemurs. The latter are allowed to walk amongst the visitors, within their compound. It was a really warm day and all of our party enjoyed the viewing of our relatives and the others were very pleased with their afternoon in Poole.

The hotel's staff, food and accommodation were all excellent, the entertainment (a different singer over three nights) were well received, not outstanding, but they did manage to get half of us on the dance floor.

On Friday we left at 10.00 a.m., and, with a small comfort break, we got home early afternoon. This would allow our Irish driver Joe, time enough to take his coach back the depot, clean and refuel it, make a half-hour drive to his home in time to see his Ireland lose against Wales 22-9.
